

# Cookie Policy on UTIP Sites

Before you start working with sites, please carefully read the following information in order to understand how we will use cookies.

## What are cookies?

A cookie is a file, usually contained of letters and numbers. This file is saved on your computer, tablet PC, phone or other device used by you to visit sites. Cookies are widely used by site owners to ensure the operation of sites or to increase work efficiency, as well as to obtain analytical information.

## What are cookies used for?

We may use different types of cookies on our sites.

Strictly required cookies. These cookies are necessary for the sites to work correctly, they will allow you to navigate through our sites and use their capabilities. These files do not identify you. If you do not agree to use this type of files, this can impact websites or their components performance.

Performance and analytics cookies. These files help us understand how visitors interact with our sites by providing information about the areas they visited and the amount of time they spent on sites. Files also show problems in the work of an Internet resource, for example, errors notification. Analytics cookie files help us to measure the effectiveness of advertising campaigns. All information collected and analyzed is anonymous.

## How long are cookies stored on your device?

Some of the cookies function from the moment you log in the site until the end of this session in the browser. When you close the browser, these files expire, and they automatically deleted. These cookies are called session cookies.

Some cookies are stored on the device and between work sessions in browser - they are not deleted after the browser is closed. These cookies are called "permanent". The shelf life of persistent cookies on a device varies for different cookies.

## Agreement to the use of cookies.

Your prior agreement to the use of session cookies is not required, as they are necessary for the sites functioning, and they expire immediately after you leave the site. Use persistent cookies with the information on settings and preferences you chose, if these cookies are not needed for sites operation, allowed only with your prior direct agreement. Navigating our sites, you agree with the persistent cookies to be used, unless you have changed computer settings in order to block such cookies installation. This rule applies to third-party cookies.

### **Cookie settings.**

You can decide for yourself whether the web server of our sites has the right to store cookies on your computer. You can always set your browser the way that cookies are not accepted and not stored on your computer. Instead, you can also configure the appearance of a warning before each direction of cookies, or set your browser to accept only cookies from certain sites. Besides, you can delete saved cookies at any time.

We draw your attention to the fact that if you reject cookies from sites, this may lead to limiting or preventing the use of certain functions of our sites. To simplify the use of sites, we recommend to set up your browser the way it accepts cookies.

### **How to manage cookies or disable them in the browser.**

The cookie management mode depends on your browser. You can find information on how to disable cookies or change cookie settings in your browser's reference materials.
